- 1. Every participant shall pay an admission fee (non-refundable) of Rs.1000/-.
- 2. We consider only duly filled and forwarded application form along with the Demand Draft of Rs. 1000.00 (Favoring Director, UGC-HRDC, Kumaun University, Nainital) on 'first come first serve basis'.
- 3. As per UGC guidelines the teachers of colleges that do not yet come within the purview of Section 12(B), but have been affiliated to a university for at least two years, will be permitted to participate in the programmes/courses. However, they won't be paid TA/DA and other allowances for attending these courses.
- 4. It is mandatory to fill in all the columns. No selection letter will be issued on the incomplete application form.
- 5. Every participant will be evaluated and grades "A" to "D" will be awarded. Participants getting grade "D" will be required to repeat the course without financial commitment to UGC-HRDC.
- 6. Part time/ Ad hoc/temporary/contract teachers who have been teaching for at least three academic sessions in an institution which has been affiliated to a University for at least two years may be permitted to participate in the Orientation Programme/ Refresher Course to enhance their skills.
- 7. Every interdisciplinary Refresher Course will be equivalent to the Refresher Course in the subject/discipline of the participant.
- 8. The Summer/Winter School will be treated as equivalent to Orientation Programme/Refresher Course.
- 9. No accommodation will be given to family members/companions of participants.
- 10. As per UGC guidelines the course will not commence, if the number of participants for each course is less than 30.
